



KingsPress Foreign Translation License Agreement (SAMPLE)

This agreement between Insert your name of Insert your company or address (hereafter “Licensee”) and KingsPress (hereafter “Licensor”), of Beach Haven, New Zealand, witnesses:

That whereas Licensor controls the international publishing rights for Insert book title by Paul Ellis:

1. Licensor grants to Licensee an exclusive license to publish (translate and sell in print, audio, electronic, and ebook formats) the Insert language here -**language** edition (hereafter the “work”) for the term and territory described in this agreement and subject to the conditions of this agreement.
2. The grant of this license shall be effective from the signing of this agreement until expiration five (5) years from the date of contract. Rights shall automatically revert to Licensor. If the work is still in print, Licensee may request an extension to this agreement, which shall not be unreasonably denied.
3. Licensee agrees to publish an accurate translation. No abridgement, alteration, or addition will be made without first obtaining Licensor’s consent.
4. Licensee shall print the author’s name on the title page of the work, the cover or jacket, and the binding, as it appears in the English-language edition.
5. In the interests of standardized promotion, Licensee shall make attempt to preserve the style (color and artwork) of the original version of Insert book title in preparing the cover of the work.
6. Licensee shall pay royalties to Licensor as follows:
 - (a) All royalties are to be paid in **US dollars (USD)**.
 - (b) A nonrefundable advance against royalty of **\$100 (USD)** shall be paid on signing the agreement.
 - (c) A ten percent (**10%**) royalty shall be paid on the retail price of print versions of the work.
 - (d) A forty percent (**40%**) royalty shall be paid on the retail price for all electronic and e-books sold.
 - (e) Royalties shall be paid yearly, accompanied by a statement of earnings by sales type. If the amount due is less than **\$100 (USD)**, Licensee may accrue the amount due to the following payment.
 - (f) All **payments are net**. Any currency conversion or transfer fees must be borne by Licensee.
7. Licensee shall publish the work within twelve (**12**) months of the date of signing this agreement. If Licensee fails to do so, Licensor may notify Licensee in writing that the license has been withdrawn.
8. Licensee agrees to submit two (**2**) copies of the work to Licensor without charge following the date of publication.
9. This agreement may not be amended except in a written document signed by both parties. This agreement shall be valid only if a fully signed copy and the advance against royalties are in the possession of the Licensor before **[Insert date one month from the date below]**.
